SURREY ARCHAEOLOGICAL SOCIETY RESEARCH FUND

This fund has been set up to support research on any aspect of the history or archaeology of the historic or administrative county of Surrey. Projects involving Surrey as part of a wider region will also be considered. The fund is available to any individual, whether or not a member of the Society and to local historical or archaeological societies or groups. The success of an application is not dependent on a proven record of research. This fund is not intended to supplant existing sources of grants (see below). EXCAVATIONS COMMITTEE GRANTS

The Society's Excavation and Fieldwork fund is administered by the Excavations Committee and exists to support archaeological work in the historic or administrative County of Surrey. Grants are available to any individual member of, or group affiliated to, the Surrey Archaeological Society and the success of an application is not necessarily dependent on a proven record of work. Applications are normally considered on a quarterly basis, but the Officers of the Committee are empowered to make an earlier decision in the case of an emergency. EXCAVATIONS COMMITTEE ANNUAL SYMPOSIUM: MARGARY AWARD

The Excavations Committee's Margary Award competition has not been as successful as had been hoped, for it has proved surprisingly difficult to encourage entries. The Committee has considered the problem and gathered comments from various sources, and has decided to change the basis of the competition. In future, the Award will be made every year for the best display at the Symposium. There will be first and second prizes of £50 and £25. Entrants must be members or (if groups) affiliated to the Society, but entry is otherwise unrestricted and may come from individuals or groups, amateur or professional. The judges will, however, take such factors into account, and they will also consider the worth of the project to which the display relates. Displays previously entered will not be eligible for a second year, but a new display can be entered relating to the same project if further project work has been undertaken. Displays may be set up as usual at the Symposium without entering for the Award, but it is hoped that as many groups or individuals as possible will take part.

Entries may be made on the usual form for booking display space which will be distributed in due course, or by telephone to the writer. THE ROMAN TILE-KILN AT HORTON, EPSOM -AN APPEAL FOR HELP

A tile-kiln was discovered during the construction of West Park Asylum at Green Man Farm, Horton, near Epsom, in May 1922. R. G. Goodchild published a short note including a plan and two sections as part of his report on the tile-kiln at Wykehurst Farm, Cranleigh (SyAC 45 (1937) 90-92). Goodchild obtained the information on the Horton kiln from Mr. W. J. Pickering, a former member of the Society who lived at 86 Alexandra Road, Epsom, and then at 9 Heathcote Road, Epsom.

BOOK REVIEW

"Surrey. Shire County Guide No. 8" by John Drewett. Published by Shire Publications Ltd. (1985). Price £1.75.

A gazetteer-type booklet of 64 pages with numerous black and white pictures. Many places in the administrative county of Surrey are described. Eight chapters survey different aspects of the county, e.g. towns and villages, archaeology, gardens, museums, etc. An amazing amount of information is packed inside the covers; the details are accurate and up to date. Within the chapters entries are listed alphabetically but a place index is also provided so that information can be located quickly. The author is a member of our Society and is also a founder-member of the Roman Villa Group. He is to be congratulated on compressing so many facts into such a readable form. Altogether an excellent "buy" for £1.75.
